DIRECTIONS FOR USE

Mixing Directions - Be sure spray tank is thoroughly cleaned, fill 1/2 full with clean water, add product and continue filling with agitation. Always add this product to tank before adding pesticides.

Compatibility - NUE Foliar is compatible with most fertilizers and pesticides. Always jar test mixes before mixing large batches.

Applications - NUE LMW Foliar can be applied by ground and aerial spray equipment, drip or overhead irrigation systems.
